Scope of work for engaging consultancy

Subject: Petition to be prepared and presented before Hon. KSERC on the Disbursal of Pension to Retired Employees and Associated Interest charged by KSERC.

1. Objective

The objective is to prepare and present a petition before the Kerala State Electricity Regulatory Commission (KSERC). The petition will address the issue of TCED, distributing pensions to its retired employees on behalf of the Government of Kerala without receiving corresponding allotments from the government. The KSERC has deemed these expenditures as unauthorized and has charged interest amounting to approximately Rs. 23 Crores for the period 2015 to 2023, treating the expenses as if, they were fixed deposits.

Scope of Work
